**THE FLU-TERROR:

Dear Readers:

You may have noticed my long silence following my decision last February “to propose a series of pieces—[this being the first](#)—that in one way or another ask the question that I put up at the beginning of this piece: ‘Can the literary life still exist in a post-1984 nation?’”

That decision took a turn that I hadn’t expected it to take: It took me away, for the moment, from writing, and led me to the formation of [The Oliver Arts & Open Press](#), a press that in a matter of only weeks will announce the publication of its first two titles.

Anyone who’s begun a business knows the kinds of time and commitment it takes. That’s what explains my silence.

But something has come up, a thing so serious, dangerous, real, and apparently imminent, that I’ve returned to help spread the word about it and raise people’s awareness in hope that their responses may still help prevent what’s a most probable-looking, albeit generally unbelievable, disaster.

In some ways it’s nothing new, since our enemies-aka-our-leaders have been using the threat of bio-weaponry as a terror-tactic against us and against the rest of the world for some time. Everyone, this past spring, knew enough to be terrified about the “Swine flu” that “broke out” in Mexico. Not everyone, however, knew that that strain of “flu” was laboratory-made, that, before being introduced to the population, it was purposely put together by scientists in order that it would contain elements of bird flu, swine flu, and plain human flu and thus be the more readily transferrable among and between species than other “conventional” flus. The model for this mix was in part the flu strain that caused the [world epidemic of 1918](#). Why it failed to produce the pandemic that was

As you begin reading, you’ll quickly see that there’s quite a difference between the “truth” as the *Times* and Obama would have us believe it to be, and the truth as it apparently really is.

If you’re still skeptical and think I’m merely alarmist and paranoid—I mean, after all, I’m saying that Our Enemies-aka-Our-Leaders are actually planning to commit genocide on us by the use of their fabricated “flu” and, more precisely, by the use of their also carefully fabricated “vaccines” for that “flu”—well, I don’t blame you for thinking I’m a nut. The aim of this work was to determine the virulence of a plasmid-derived human 1918 pandemic H1N1 influenza virus (reconstructed 1918, or 1918/rec, virus) in swine using a plasmid-derived A/swine/Iowa/15/1930 H1N1 virus (1930/rec virus), representing the first isolated influenza virus, as a reference.

Baxter working on vaccine to stop swine flu, though admitted sending live pandemic flu viruses to subcontractor 26 Apr 2009 Specialty drug maker Baxter International Inc. will work with the World Health Organization to develop a vaccine that could stem an outbreak of a deadly swine flu strain in Mexico. Baxter spokesman Christopher Bona said Saturday that the Deerfield, Ill., based company has asked the WHO for a sample of the flu strain. He says Baxter has patented technology that allows the company to develop vaccines in half the time it usually takes—about 13 weeks instead of 26.

We also recognize the hazards of an untested, unchecked, unnecessary and possibly deadly vaccine:

Administration readies \$350 million for state, local responders to combat flu pandemic—The Obama administration said today that it has billions of dollars available to help pay for a national H1N1 flu vaccine program that could be ready starting in mid-October. 08 Jul 2009 Health and Human Services Secretary Kathleen Sebelius made the announcement at an all-day summit on the outbreak of what is more commonly known as swine flu. Sebelius said the government has "already appropriated about a billion dollars to buy the [bulk ingredients](#)" [i.e., influenza viruses, Neomycin, Polymyxin, Gentamycin, Thimerosal (mercury), Betapropiolactone, Nonoxynol, Octoxinol 9, Formaldehyde - yum yum! -LRP]

H1N1 Flu: UK to vaccinate 30 people an hour in 'military-style operation'— Swine flu vaccine to be cleared after five-day trial 12 Jul 2009 It will be introduced into the general population while regulators continue to carry out simultaneous clinical trials. The first patients in the queue for the jab—being supplied to the UK by GSK and Baxter Healthcare—may understandably be a little nervous at any possible side effects. A mass vaccination campaign against swine flu in America was halted in the 1970s after some people suffered Guillain-Barré syndrome, a disorder of the nervous system.

Everyone will get vaccine against swine flu 12 Jul 2009 The NHS is preparing to vaccinate the entire population against swine flu after the disease claimed the life of its first healthy British patient.

Homeless people die after bird flu vaccine trial in Poland—Three Polish doctors and six nurses are facing criminal prosecution after a number of homeless people died following medical trials for a vaccine to the H5N1 bird-flu virus. 02 Jul 2008

Lastly, we will not succumb to any forced flu shots:

The Truth about the Flu Shot 10 Jul 2009 If the government mandates a series of flu shots this fall—so far they are only "recommending%u201D the shots—you can expect to get a dose of thimerosal (mercury), formaldehyde, detergent, MF-59 (an oil-based adjuvant), and other toxins. Incidentally, if you believe the government will not kidnap you at gunpoint and lock you in a concentration camp and possibly force you to take these toxins, check out [Executive Order 13295](#) of April 4, 2003. It states that the government has the authority to establish "regulations providing for the apprehension, detention, or conditional release of individuals to prevent the introduction, transmission, or spread of suspected communicable diseases," including diseases at that time "not yet isolated or named." Of course, the government will decide if you have a deadly disease or not.
